About this privacy statement

The Beautiful Children's Rhymes website is owned and operated by Red Flash Pty Ltd (trading as Beautiful Children's Rhymes) under the domain name www.beautifulchildrensrhymes.com

This Privacy Statement applies to the Beautiful Children's Rhymes website. It explains how your personal information will be treated as you access and interact with the Beautiful Children's Rhymes website.

Security of information

Beautiful Children's Rhymes takes reasonable steps to preserve the security of cookies and personal information. Unfortunately, no data transmission over the Internet can be guaranteed as totally secure. Accordingly, although Beautiful Children's Rhymes strives to protect such information, Beautiful Children's Rhymes cannot ensure or warrant the security of any information you transmit to us, and you do so at your own risk.

Information collected

The information that Beautiful Children's Rhymes collects about you depends on how you use the facilities offered by the Beautiful Children's Rhymes website.

If you visit an unsecure area of the Beautiful Children's Rhymes website (that is, an area where you are not required to log on) to read, browse or download information, or to view video or audio files, our system will record the date and time of your visit to the site, the pages viewed and any information or files downloaded. However, our systems will not record any personally identifiable information.

We will ask you to submit certain personal information if you choose to register on the Beautiful Children's Rhymes website, or to purchase a product or service offered on the Beautiful Children's Rhymes website. If you choose not to provide this personal information, Beautiful Children's Rhymes may not be able to provide you with access to the product or service.

If you decide to register on the Beautiful Children's Rhymes website, or to purchase a product or service from the Beautiful Children's Rhymes website, then we will collect and retain the information that you submit to us in the course of registering or purchasing that product or service.

The Beautiful Children's Rhymes website also contains links to the websites of third party providers of goods and services (**Third Party websites**). If you have accessed Third Party websites through the Beautiful Children's Rhymes website and if those third parties collect information about you, Beautiful Children's Rhymes may also collect or have access to that information as part of our arrangements with those third parties.

Third party websites should contain their own privacy statements, and those third parties are responsible for their own privacy practices.

Use and Disclosure of Information

We will only use or disclose personal information or information generated by cookies in accordance with specific additional provisions relating to privacy which apply to certain areas of the Beautiful Children's Rhymes website and as otherwise set out in this Privacy Statement.

We collect personal information about you that is necessary to perform our functions and activities. If you do not provide this information, we may not be able to deal with you, or provide you with a product or service.

We may collect your personal information to: verify your identity; assist you to use our services; provide the services you require; administer and manage those services; offer new services to you; and maintain our relationship with you.

We may disclose under confidentiality agreements some aspects of your personal information to other organisations. These organisations may carry out our customer enquiries; mailing operations; billing functions; information technology services; marketing services; and website usage analysis.

Though we make every effort to preserve user privacy, we may need to disclose personal information when required by law, courts, government agencies, law enforcement bodies, and other regulatory bodies. We may also disclose personal information in connection with any investigation or complaint regarding your use of the Beautiful Children's Rhymes website, or in connection with legal action regarding injury to the Beautiful Children's Rhymes website or Beautiful Children's Rhymes rights or property.

We will not sell or disclose your personal information to spammers or direct marketing operators.

Cookies

The Beautiful Children's Rhymes website may use 'cookies'. Cookies are an industry standard and most major web sites use them. A cookie is a small text file that our web sites may place on your computer. Usually, cookies are used as a means for the Beautiful Children's Rhymes website to remember your preferences. In some cases, cookies may collect and store personal information about you.
